- Represents withholding of ordinary shares for the tax liability associated with the vesting and settlement of a portion of the restricted stock units (RSUs) granted on May 12, 2017.
- These options vest in three equal annual installments beginning on March 2, 2019 and expire on March 2, 2028.
- Each RSU represents the right to receive one ordinary share of Mylan N.V. 7,811 of the RSUs will vest on March 2, 2019, 7,810 will vest on March 2, 2020, and 7,811 will vest on March 2, 2021.
- Each RSU represents the right to receive one ordinary share of Mylan N.V. 8,218 of the RSUs granted on May 12, 2017 vested on March 3, 2018, and 8,218 will vest on each of March 3, 2019 and March 3, 2020.
